None of the content of any of these videos is true in any way and absolutely no proof of any kind is offered by Smith to back up his slanders, ERGO I am suing him for libel, slander and defamation in Cebu as that is my Philippines Home Base.

Smith calls upon his following to do myself and my family as much harm as they can and to write, email, telephone and contact anyone who knows me to do me and my family harm.

is to his most ardent supporter in America who is a convicted criminal who has been sent to Prison for aggravated violent assault. The same person has been shamed out of his own neighbourhood after posters of his criminal behaviour were posted all around that area. Smith calls this person a voice of fresh air and reason, so if you can satisfy yourself this is the character you wish your students exposed to then please justify it? Watch any of these videos to make your own mind up but more importantly--read the insane comments printed under his videos, all false, slander and Smith encourages.

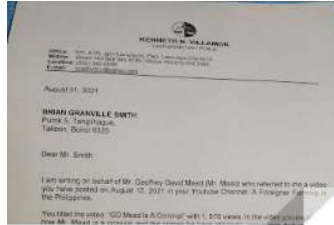
I hope this information into the character of this vile man your College is now promoting proves inciteful?

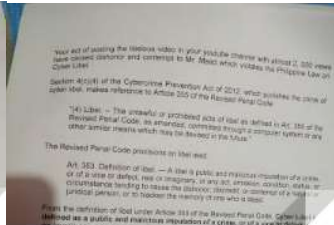
