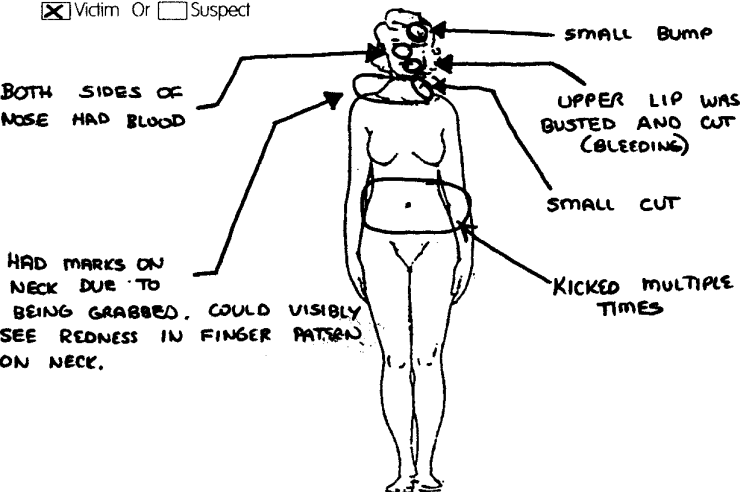
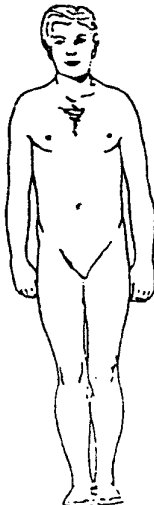

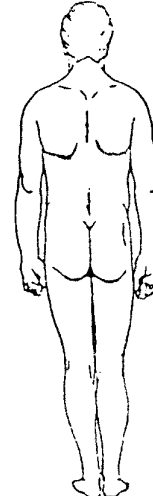

ON DECEMBER 9, 2008 I RESPONDED TO 152 PRESCOTT IN REFERENCE TO A DOMESTIC DISTURBANCE. UPON ARRIVAL I FOUND THAT MRS. GRESHAM WAS IN BACK BEDROOM WAITING FOR UNITS ARRIVAL WATCHING OUT WINDOW. I HAD BEEN TO RESIDENCE PREVIOUSLY FOR DOMESTIC DISTURBANCE. TONIGHT I FOUND MR. MARTIN ON SOFA IN LIVING ROOM WATCHING TELEVISION. I WENT IN AND ASKED WHAT WAS GOING ON AND WAS ADVISED HE DID NOT KNOW.

I THEN WENT AND SPOKE TO MRS. GRESHAM WHO ADVISED THAT MR MARTIN WANTED TEN DOLLARS. SHE DID NOT GIVE HIM TEN DOLLARS AND HE BECAME ANGRY STATING THAT HE HAD GAVE HER MONEY. SHE ADVISED THAT HE THEN GRABBED HER ENDING UP IN FIGHT. SHE EXPLAINED THAT "HE LOST IT". SHE ADVISED THAT HE HIT HER MULTIPLE TIMES, KICKED HER WHEN SHE FELL TO GROUND, AND CHOKED HER. THIS OCCURED ABOUT AN HOUR PRIOR TO PHONE CALL. SHE ADVISED THAT AFTER BEATING HER HE KEPT CELL PHONE WITH HIM. SHE WENT TO ATTEND HER WOUNDS.

SPEAKING TO MR MARTIN AGAIN HE ADVISED THAT THEY HAD ARGUMENT OVER MONEY. HE WOULD NOT ADVISE ANYTHING ELSE. I PLACED HIM UNDER ARREST FOR FAMILY VIOLENCE BATTERY. I THEN GOT PHOTOS OF INJURYS, CLOTHING (BLOOD STAINED), SCENE (WHICH WAS PARTIALLY CLEANED UP) AND RAG. MRS GRESHAM ADVISES THAT SHE IS AFRAID WORSE WILL HAPPEN WHEN HE GETS OUT OF JAIL. I PROVIDED VICTIM RIGHTS PHAMPLET AND CASE NUMBER TO HER. MR MARTIN HAS APPEARED TO HAVE A ANGER PROBLEM IN ALL MY DEALINGS WITH HIM.

On 12-10-2003 at 0815 I received this case for follow up investigation. I checked ACCPD records via AS-400 and found 4 prior reported domestic violence incidents involving the suspect. The last 2 were reported by the victim in this case. (See case file.) At 0848 I called the victim's cell phone number and left a voice mail message. At 0850 I called her work number but she did not come in. At 0950 I went to the victim's residence and made contact with her there. She agreed to provide a statement and I recorded the interview on micro cassette. The victim, **Shirley Gresham**, gave the following account: *The suspect is the victim's ex-boyfriend. They had broke up but were back together trying to work things out. He was staying with her at her apartment at 152 Prescott Court but he was not on the lease. They do not have any children. She has known him about 3 years. On Tuesday 12-09-2003 they had been fighting off and on all night. The suspect came home from work at about 5:00 p.m.. The victim was laying on the couch. He wanted to pick up an argument but she did not pay him any attention. He went in the kitchen to fix something to eat and then came back in the living room and sat down. The victim asked him if he was going home because he wanted to argue. She told him it was time for him to go home and he got mad. He stated "Give me \$20." And the victim told him "I don't have no money. I have to pay my rent tomorrow." He went on cussing and she asked him if he was going to get a ride home. She told him to go ask her neighbor for a ride home. The suspect stated "You think I'm playing with you don't you? You think if gonna give you all my m----- f----- money and when I ask you for something you can't give me shit?". The victim stated "Gary, I told you. What you want me to do, get put out doors?". The suspect then came at her and pulled her by her hair. They were in the kitchen area at that point because she was trying to get away from him. She told him to leave her alone. Finally he let her hair go and he was cussing her out. He started over again and it kept repeating. He kept saying "You think I'm playing with you?" and the victim would argue back with him. The suspect "would get out of hand with it". The victim picked up a little rock off the table and tried to bust him in the head with it so he would leave her alone but she never did hit him with it. She told him "I ain't playing. You better leave me alone.". He was fixing to leave one time and he was looking to see if her*

neighbor was home. The victim stated "That's right, he's at home. Go on over there and get him to take you home Because I want you out of here.". Her neighbor's name is Tommy and he stays in the first duplex on the right on Prescott Court. No one lives in the other side of the victim's duplex. The suspect stated "You think I'm playing with you? Don't you bitch?". The victim stated "Bitch? I ain't nobody's bitch.". The suspect started coming at her and he grabbed her by her hair and threw her down on the sofa. The victim covered up her head and the suspect started throwing punches "like a punching bag". He kneed or kicked her in her side. The victim ripped off his shirt to get him off of her. The suspect then tore the shirt on off. The victim moved over to the left side of the sofa trying to get away. While she was on the sofa he started choking her. He was shaking her a lot while he did it. He used both hands and he was on top of her facing her. He choked her for a couple of minutes and she had trouble breathing. She felt faint but did not pass out. Afterwards she had some pain in her throat and she was spitting up some blood. She stood up in his face, put her finger to his forehead, and stated "Why don't you leave me alone and get the f--- out my house?". He pushed her back down on the sofa. She looked up and the suspect punched her right in her mouth and nose. Her nose started bleeding and he got on top of her. She told him that her nose was bleeding and he stated "Your nose ain't bleeding. That's your mother fucking mouth.". He was still trying to punch her. She told him "No, my nose's bleeding to.". She could see the blood. She told him to get off her. She pushed him off and got up and was shaking. She took her shirt off and put it over her nose and mouth. The suspect went and got a wash cloth for her. She said she did not want it and told him to leave her alone. He got on his knees and told her he loved her and wanted to take the rag and clean her face up but she would not let him. He stated "See? That's the goddamn shit I'm talking about! You do not listen to me! You so mother fucking stubborn! You want to be a hard ass woman! You want to be like a nigger, you don't want to be like no woman!". After that the victim had to phone with her on the sofa. He was trying to put ice on her but she kept throwing it away. She pretended like she was going to sleep and got her cell phone. She put it under the covers and tried to call 911. The suspect asked her "Who you mother fucking calling?" and she said

"I ain't calling nobody.". He jerked the phone away from her and sat on the sofa with her. She told him to leave and he said "I ain't going nowhere.". She told him "Gary, I tell you what. I'ma put you in jail if you don't go nowhere.". He stated "Well, I ain't going nowhere and you ain't gonna put me in jail.". She tried to make him think everything was ok. She pretended like she was trying to call someone else, then acted like she was putting her cell phone on the charger in her room. She went back in the living room and asked the suspect if he was going to leave and he said no. She told him she was going to bed and she went in her room and called 911. The suspect has fallen asleep and the victim waited until the officers knocked on her door. She turned the light on and let the officers in.

I asked the victim what she wants to see happen from here. She stated that she does not know if the suspect knows what he is doing. She stated that she thinks he needs help. I asked her if she still want to be with him and she said "No, no, no. Cause I don't want him to kill me, cause he told me ... No, no, no. I don't want to be with him no more.". I asked the victim about the lease and she said the suspect is not on the lease. She gave me the number for her landlord, 353-7508. I observed that the victim had a scratch on her forehead and the inside of her upper lip was busted. I took digital photos of her injuries which I saved to a CD-R.

At 1605 I spoke with the victim's landlord, **Nomglak Supakorndeg**, by phone. She confirmed that the victim is the only one on the lease for that address. She faxed me a copy of the lease. (See the case file.)

On 12-11-2003 at 1045 a bond hearing was held in Magistrate's Court before Judge Patricia Barron. The suspect was given a \$5000 bond and was ordered to have no contact with the victim and to stay away from her residence. The suspect told the judge that he had things he needed to pick up. She told him to arrange for his mother to pick them up. On 12-14-2003 at 0655 the suspect bonded out.

On 12-18-2003 at 1635 he was back in the Clarke County Jail on an agency hold from Rockdale County.
